ORDINANCE NO. _____

1 WHEREAS, the U.S. each year generates more than 4 million tons of plastic bags, sacks
2 and wraps, according to the Environmental Protection Agency, and only about 13 percent of that
3 plastic is recycled;

4
5 WHEREAS, single-use plastic bags eventually make their way to landfills and into our
6 oceans, adding to the 8 million metric tons of plastic entering the ocean every year;

7
8 WHEREAS, the majority of single-use plastic bags and polystyrene containers do not
9 biodegrade but rather persist in the environment for hundreds of years, even though they are only
10 used for a few minutes; and

11
12 WHEREAS, thousands of single-use plastic bags and polystyrene containers contribute to
13 public litter;

14
15 WHEREAS, the production of polystyrene creates greenhouse gases and polystyrene
16 products take more than 500 years to degrade, even though they are only used for a few minutes;

17
18 WHEREAS, single-use plastic bags, when mistakenly placed in recycling bins, often jam
19 recycling equipment resulting in work stoppages and loss of efficiency at recycling facilities;

20
21 WHEREAS, major American companies have announced plans to end the use of
22 polystyrene cups and containers; and,

23
24 WHEREAS, at least 350 local governments in the United States have banned the use of
25 single-use plastic bags and major retailers have announced plans to end the use of single-use
26 plastic bags in all stores by 2025.

27
28 **Section 1. Purpose**

29
30 The production and disposal of single-use plastic bags and single-use polystyrene containers
31 create significant environmental impacts including the contamination of the environment,
32 ingestion and entanglement by wildlife, and widespread litter. Single-use polystyrene containers
33 create non-recyclable and non-degradable refuse streams while more environmentally sensitive
34 alternatives are available. The purpose of this Ordinance is to protect and enhance the County’s
35 unique and precious environment, wildlife, and beauty through the reduction of single-use non-
36 compostable or non-recyclable bags and containers, and to encourage the use of reusable or
37 sustainable options.

39 **Section 2. Applicability**

40

- 1 A. A retail establishment shall not provide at the point of sale a single-use plastic carryout
2 bag or single-use polystyrene container to any customer.
- 3 B. A retail establishment shall provide only the following carryout item types at checkout to
4 customers: reusable bags, reusable containers, recyclable paper bags, recyclable
5 containers, and/or cardboard boxes.
- 6 a. The retail establishment shall post at the point of sale or on each bag a notice that
7 the bags and containers issued pursuant to this Ordinance are recyclable and/or
8 compostable and encouraging recycling of the bags and containers.
- 9 b. Nothing in this section shall be read to preclude retail establishments from making
10 reusable bags and containers available for sale to customers.
- 11 C. All County retail establishments are encouraged, but not required, to post notices
12 encouraging customers to bring their own reusable shopping bags.
- 13 D. This Ordinance shall not be construed to apply to plastic wrappings, bags or containers
14 distributed by the manufacturer for packaging or preparing goods for display prior to sale.

17 **Section 3. Definitions**
18

- 19 A. “Single-use plastic carryout bag” is defined as a plastic bag provided at the check stand,
20 cash register, point of sale, or other point of departure for the purpose of transporting
21 food or merchandise out of the establishment. Single-use carryout bags do not include
22 bags without handles provided to the customer (1) to transport produce, bulk food, candy,
23 or meat from a product, bulk food, or meat department within a store to the point of sale;
24 (2) to hold prescription medication dispensed from a pharmacy; (3) to segregate food or
25 merchandise that could damage or contaminate other food or merchandise when placed
26 together in a bag; and (4) to transport clothing items from a dry cleaning establishment.
- 27 B. “Retail establishment” means any retail business including, but not limited to, a
28 convenience store, restaurant, grocery store, pharmacy, home improvement stores, liquor
29 stores, gas stations, seasonal or temporary business, farmers market or farm stand, and
30 seller of merchandise and dry goods to the consumer. For purposes of this Ordinance,
31 food banks and dry cleaners are not defined as retail establishments.
- 32 C. “Single-use polystyrene container,” for purposes of this Ordinance, is defined as a
33 disposable food service container designed for one time use and made from polystyrene
34 foam. A disposable food service container includes service ware for take-out foods,
35 packaged meat, eggs, bakery products, and leftovers from partially consumed meals
36 prepared by food vendors. Polystyrene foam is blown polystyrene and expanded or
37 extruded foams using a styrene monomer.
- 38 D. “Reusable bag” is defined as a bag with handles that is specifically designed and
39 manufactured for multiple reuse and is made of durable material suitable for reuse.
40

41 **Section 4. Authorizing a bag fee**
42

- 43 A. Retail establishments may charge a fee of up to 5-cents (\$.05) per approved bag or
44 container issued to customers pursuant to this Ordinance.

1 **Section 5. Enforcement**

- 2
- 3 A. Any owner of a retail establishment found in violation of any provision of this ordinance
- 4 is subject to the following penalties
- 5 a. A formal warning for the first offense;
- 6 b. A civil fine of \$100 for the second offense;
- 7 c. A civil fine of \$250 for third offense and subsequent offenses.
- 8 B. Each calendar day during which the civil violation occurs shall constitute a separate and
- 9 distinct offense.
- 10 C. Any County employee authorized to enforce codes and ordinances shall be empowered to
- 11 enforce this ordinance, unless otherwise directed by the Board of County Commissioners.
- 12 D. Any person who is found in violation of this Ordinance may request a hearing be
- 13 scheduled by a county hearing officer. The request shall be made in writing to the
- 14 Bernalillo County Business License Clerk within 15 business days of the formal
- 15 violation. The hearing shall be held within 20 working days (excluding weekends and
- 16 holidays) of receipt of the request unless the hearing is continued with the agreement of
- 17 the parties. The County hearing officer shall determine whether a violation of this
- 18 Ordinance occurred. The hearing officer shall mail a written notice of decision to the
- 19 owner within five (5) working days of the hearing. If the hearing officer determines a
- 20 violation of this Ordinance did occur, the hearing officer shall impose the fine as
- 21 prescribed. If the hearing officer determines a violation did not occur, the imposition of a
- 22 fine will be removed and no fine will be imposed.
- 23 E. Failure to pay a fine imposed by this article may prevent the issuance of a business
- 24 license or business license renewal.
- 25

26 **Section 6. Requiring an impact study within 2 years**

- 27
- 28 A. During the second-half of FY 2022, a temporary administrative committee shall convene
- 29 to evaluate the impact of this ordinance and present a report to the Board of County
- 30 Commissioners before June 30, 2022.
- 31 B. The Committee shall include:
- 32 a. The County Attorney, or his/her designee;
- 33 b. The Solid Waste Program Manager, or his/her designee;
- 34 c. The Public Works Division Deputy County Manager, or his/her designee;
- 35 d. The Chair of the Board of County Commissioners, or his/her designee;
- 36 e. The County Manager, or his/her designee; and,
- 37 f. A member of the business community, appointed by the commission.
- 38 C. The report shall, at a minimum and as well as can be reasonably determined, determine
- 39 the number of prohibited single-use plastic carryout bags and single-use polystyrene
- 40 containers diverted from the public waste stream by this ordinance, the number of bags
- 41 and containers sold or distributed at the point of sale, and the percentage of customers
- 42 using reusable bags on a regular basis. The committee shall also make recommendations
- 43 for changes to this act.
- 44

45 **Section 7. Public Education**

1 No less than 180 days prior to the effective date, the Board of County Commissioners shall
2 initiate a public education campaign about the new regulations, encouraging the use of reusable
3 or sustainable options and the recycling of permitted single-use items.
4

5 **Section 8. Severability Clause.**
6

7 If any section, paragraph, sentence, clause, word or phrase of this ordinance is for any reason
8 held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall
9 not affect the validity of the remaining provisions of this Ordinance. The Commission hereby
10 declares that it would have passed this ordinance and each section, paragraph, sentence, clause,
11 word or phrase thereof irrespective of any provision being declared unconstitutional or otherwise
12 invalid.
13

14 **Section 9. Compilation.**
15

16 The Ordinance amendment prescribed by Sections 1 through 8 shall amend, be incorporated in,
17 and made part of the Bernalillo County Code.
18

19 **Section 10. Effective Date.**
20

21 This Ordinance shall take effect after publication by title and general summary on January 1,
22 2020.
